

**NOTICE ON THE EXECUTION OF THE SHARE BUYBACK PROGRAMME DURING THE PERIOD BETWEEN 16 AND 20 FEBRUARY 2026**

**Jolanda di Savoia (FE), 23 February 2026** – With regard to the implementation of the share buyback programme disclosed to the market on 9 January 2026, B.F. S.p.A. (the “**Company**”) communicates – in accordance with the provisions of article 2, paragraph 3 of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 (the “**EU Regulation 2016/1052**”) – the purchase, on the Euronext Milan Market organized and managed by Borsa Italiana S.p.A., during the period between 16 February 2026 and 20 February 2026, both dates included, of 9,510 shares (equal to 0.004% of its share capital), at a weighted average price per share of Euro 4.4847, for a total amount of Euro 42,649.91.

Based on the information provided by the intermediary appointed to execute the purchases, here below a summary of the transactions on a daily basis:
